### Funding News

The **Ontario Seniors' Secretariat (OSS)** formally launched the fourth year of the **Seniors Community Grant Program**. The first grant program in Ontario dedicated solely to seniors, is designed to give seniors more opportunities to participate in their communities by providing funding to not-for-profit community groups for projects that encourage greater social inclusion, volunteerism and community engagement for seniors.

Within this year's program (under Priority 2), is renewed attention to projects focusing on raising public awareness about and prevention of elder abuse, specifically, to **"raise awareness about the issue of elder abuse and inform seniors about available resources"**.

The funding streams range from \$3000 for unincorporated EA Networks, to a maximum \$8000 for the execution of an elder abuse project, provided that the lead applicant is an incorporated body, with conditions (applicant may receive the majority of their annual operating base funding from the province and may only use the Seniors Community Grant Program funding to deliver the approved elder abuse grant project).

Applications will be accepted **starting November 25, 2016, with a deadline for submissions on March 3, 2017 at 5:00 p.m.** [Learn how to submit your applications here](#)

### A National Action Plan

Three National health care organizations today released a comprehensive set of actions to enhance home care in Canada. The Canadian Home Care Association (CHCA), the Canadian Nurses Association (CNA) and the College of Family Physicians of Canada (CFPC) launched ***Better Home Care: A National Action Plan***.
